



2024 Contribution Receipts

The RRSP contribution deadline for the 2024 taxation year is Monday, March 3, 2025. RRSP contribution receipts for the remainder of 2024 (encompassing all contributions made between March 1, 2024, and December 31, 2024) will be mailed by the end of January. All RRSP contribution receipts for the first 60 days of 2025 (encompassing all contributions made January 1, 2025, to March 3, 2025) will be consolidated and mailed together by the 3rd week of March. Please note that electronic copies of the RRSP contribution receipts will be available on our website for viewing and retrieval by the end of January 2025, with new receipts being posted on a weekly basis as they become available for contributions made in the first 60 days of 2025.

T4FHSA/RL-32 tax slip for FHSA contributions are expected to be mailed by February 28, 2025.
